

Application for a STUDENT CARD

University of Hradec Králové

According to Law No. 111/1998 Coll., as amended (Section 57), a student card is considered one of the proofs of study. The University of Hradec Králové (hereinafter referred to as "UHK") issues two types of the card: the identity card with the ISIC license and the identity card without the ISIC license. Students are allowed to own only one type of card (of their choice). Both types of the card entitle students to use the services provided by the UHK to the extent that will be kept updated on the website of the section of Information, Communication & Multimedia (hereinafter referred to as IKM UHK)- (http://www.uhk.cz/karty), and the services of other entities outside the university. The use of student cards is regulated by the Rector's Order No. 16/2010. The card is issued in the form of a smart card by the UHK in cooperation with Komerční banka, a. s. (Commercial Bank).

Only a student of full-time study can become the holder of the identity card with the ISIC license. The validity of the ISIC license must be extended by the revalidation mark, without which the card is invalid.

For the issue of the identity card it is necessary:

- 1) to fill in the identification data legibly
- 2) to attach an authentic photo of the identity card type of the size 35x45 mm (on the back of the photo indicate the applicant's personal identification number legibly)
- 3) to sign the consent of storage and processing of personal data

The application must be submitted to **the contact point of IKM UHK** (Building of Common Education—building No. 3, Hradecka 1227, the door number 1190) or sent by email to the following address: **University of Hradec Králové, ID cards IKM, Rokitanského 62, 500 03 Hradec Králové 3.** The card will be issued 15 working days after the receiption of the request by the officer of the contact point of IKM UHK.
