Title: An introduction to international security in Latin America.

Intent:

Since the end of the cold war, Latin American international security has changed. The United States focused on the Middle East which gave Latin-Americans an opportunity to experiment their own solutions to some specific problems. Along the course of 8 hours, the introduction will present Latin America during the Cold War period, center the attention on the role of the UN and the “war on drugs” during the nineties, the creation of the UNASUR and Alianza del Pacífico, and close our presentation talking about climate change and the pandemic as the decade starts.
