

# Scholarship Regulations of the University of Hradec Králové applied by the Faculty of Education of the University of Hradec Králové

This Directive (translation of Czech version: Směrnice děkana č. 7/2020) is issued in compliance with Article 2, paragraph 1 a) of the Scholarship and Bursary Rules of the University of Hradec Králové (hereinafter only SBR UHK), and it is binding for all students enrolled in study programs accredited at the Faculty of Education of the University of Hradec Hradec Králové.

## Section 1 **General provisions**

- 1) This Directive supplements SBR UHK.
- 2) This Directive may be further specified and amended through the Dean's decisions, in particular with information of an organizing character.

## Section 2 Scholarship for excellent study results (Article 3 of SBR UHK)

1) For the academic year 2020/2021, the limit of the weighted average within which the scholarship for excellent study results in the previous academic year is awarded is 1.50. The individual groups are determined as follows:

Group 1 – weighted average 1 – 1.10

Group 2 – weighted average 1.11 – 1.20

Group 3 – weighted average 1.21 – 1.30

Group 4 – weighted average 1.31 – 1.40

Group 5 – weighted average 1.41 – 1.50

2) The total amount to be paid is 3,000,000,- Czech crowns (CZK). The scholarship for excellent study results will be calculated on the basis of the number of students in each group:

Group 1 – amount 3x – the number of students in the group: e

Group 2 – amount 2.5x – the number of students in the group: d

Group 3 – amount 2x – the number of students in the group: c

Group 4 – amount 1.5x – the number of students in the group: b

Group 5 – amount x – the number of students in the group: a

Formula for calculating of x: ax + 1.5bx + 2cx + 2.5dx + 3ex = 3000000

#### Section 3

### **Scholarship awarded in extraordinary cases** (Article 4 of SBR UHK)

1) Graduates are awarded a scholarship for excellent study results at the end of their studies (the overall evaluation of the duly completed studies is "passed with distinction" in accordance with Article 28, paragraph 1 of the Study and Examination Regulations of the University of Hradec Králové). The financial amounts paid are: 6,000,- Czech crowns (CZK) in Bachelor's degree study programs, 4,000,- Czech crowns (CZK) in follow-up Master's' degree study programs and 10,000,- Czech crowns (CZK) in Master's degree study programs.

- 2) Scholarships in cases worth considering can be awarded to students for participation in the activities carried out for / at the Dean's office, for /at departments, institutes and other parts of the Faculty, or for participation in events organized by all these mentioned above. The decision about awarding the scholarship is made by the Dean on the basis of a proposal made by the head of the departments / the head of the institute or the guarantor of the organized event.
- 3) The decision about awarding the scholarship in support of international mobility is made by the Dean on the basis of a proposal made by the Vice-Dean for internationalization. This proposal also includes the financial amount to be awarded. This amount must be within the specifically determined limit of the amount of the scholarship in support of international mobility and is specifically determined by the relevant decision made by the Dean. In exceptional cases, the mobility scholarship may also be increased in case of mobilities financed from other sources. A potential increase in the amount cannot be claimed, and it depends on the nature and content of mobility, its benefits for the student's professional development, its scientific, artistic, creative benefits for the study programme and for the Faculty of Education. These facts are reflected in the mobility plan or within the framework of the application for this scholarship.
- 4) Foreigners may be awarded a scholarship to support their studying in the Czech Republic. The conditions for awarding this scholarship and the financial amount to be paid are determined by the Dean on the basis of a proposal made by the Vice-Dean for internationalization.
- 5) Other extraordinary scholarships are awarded by the Dean of the Faculty at the request of students or at a proposal made by the head of the relevant department or the head of the institute. The proposal must include a justification of the application and the proposed amount of the scholarship.
- 6) Within 30 days after receiving a proposal, the Dean will issue his / her decision on awarding / not awarding the scholarship, or on awarding a different financial amount. If the applications are delivered in July and in August, the Dean will issue his / her decision by September 30<sup>th</sup> of the same year.

## Section 4 **Concluding Provisions**

- 1) Scholarship is wired to the bank account designated by the student. The Dean of the Faculty may, in justified cases, decide about another way of the payment of the scholarship.
- 2) These Regulations enter into force and shall apply from December 1st 2020.
