# **APPLICATION PROCEDURE**

Students must be officially nominated by the International office/coordinator at the home institution, via email, before they apply.

Nomination email should include: name, surname of student/s, study cycle, subject area, email address, which semester.

Application documents must be complete, filled-out, signed and stamped by students and coordinators of home institution for the application to be processed.

### STUDY COURSES FOR ERASMUS+ STUDENTS

Incoming students choose courses from their receiving faculty. However, it is also possible to register for courses from other faculties. In that case courses that correspond to at least 75% of credits selected by the student have to be registered at the receiving faculty.

Faculty of Education offers the module-oriented courses, taught in English (partly in German, French and Russian.)

All exchange students are recommended to enrol the course of the Czech for Foreigners.

This course is held as a semester course and is intended for beginners (no Czech language knowledge) or for slight advanced (basic Czech language knowledge).

Students could choose courses, either single courses or whole modules, or combination of them, according to their requirements.

Students are recommended to enrol Czech for Foreigners course (crash course for beginners, in case of interest and minimum number of interested students, there might be also offered course for advanced students (A2-B1). You can set up your study plan on basis of whole modules, or single courses or in combination of e.g. one module+additional single courses from other modules.

You must enrol at least 20 ECTS, maximally 30 ECTS (only in exceptionnal cases, it might be more).

In addition to the course offer of the Faculty of Education, you could also choose courses of other faculties of the UHK, then the receiving one. Look at the UHK Course Catalogue 2022-23 (see attached).

However, that is rule that minimally 75% of courses/credits must be chosen from the receiving faculty, so from the Faculty of Education! If not kept, your study plan will be the subject of change or you might be refused from studies.

Faculty of Education also provides the internship as a semester tailor-made traineeship stay (at school, informal education organization, leisure centre, etc.)

# **GRADING SYSTEM**

The European Credit Transfer and Accumulation System ("the ECTS") with grades A, B, C, D, E, and F is used for grading. Grade A is the best one while grade F means that the student failed.

The following table can be used at the UHK to compare the ECTS grading with grading by words and numbers:

ECTS grading	Grading by words and numbers
A	Excellent (1)
В	Very good (1.5)
С	Good (2)



D	Satisfactory (2.5)
Е	Sufficient (3)
F	Failed (4)

When recognizing a part of the study or the individual subjects under Article 21 (1), the word "recognized" can be used instead of grading.

### **ACCOMMODATION**

Accommodation is provided by UHK, in the Palachova student dormitory (residence hall). Students stay in the two-room flat with shared kitchen, bathroom and toilet. Rooms are double or triple. We do not provide single rooms. Furnished with bed, table, chair and wardrobe. Bedlinen, cuvet, pillow and sheet are provided.

The rent of room differs from 93 to 118 CZK per day and per person (in double and triple rooms). So that, please, count with the price around 2900-3600 CZK/month (= approx. 120-140 EUR). Gas and electricity are included in the fees.

Housing deposit of 2000 CZK (that is approx. 75 EUR) including rent for whole semester is required to be paid by student upon arrival.

In case of stays shorter than 60 days, additional city tax is applied (15 CZK per day, that is approx.0,55 EUR per day).

Students apply for housing by ticking it in the standard application form.

The accommodation is guaranteed only for students who keep the deadline for applying:

1st SEMESTER (WINTER SEMESTER)	31st MAY (15th MAY FOR VISA STUDENTS)
2nd SEMESTER (SUMMER SEMESTER)	30th NOVEMBER (31st OCTOBER FOR VISA STUDENTS)

If students do not apply for housing in a due time or prefer single room or private housing, they are supposed to arrange it on their own.

Please note that the accommodation in the Palachova student dormitory will be available **only from 7th September 2022 till 26th January 2023 for 1st/winter semester stays**, while the accommodation **for summer semester stays** will be available **not before 1st February 2023**.

### **PRACTICAL INFORMATION**

All accepted exchange students will receive a welcome email with practical, pre-arrival information about visa application, travelling, arrival, accommodation, enrolment, university and town.

Official currency in the Czech Republic is CZECH CROWN=CZK (1 EUR= approx. 26 CZK) (Euro is **not** accepted in most of shops, restaurants or public places).

Living costs: Housing 120-140 EUR/month (the price at the student dormitory, at

triple shared room)

250-450 EUR/month (in private facility)

Food 150-200 EUR/month

Local Transportation 25 EUR/month (many places in the town are at walking

distance, or you can buy and use bike)

School Fees none or very small (student card is for free, students only

pay for some printing or copying, if needed)

Visa requirements: Citizens of the EU, Norway, Lichtenstein, Iceland and Switzerland do not need to apply for a

residence permit/visa.



Citizens from countries outside of the EU need to apply for a visa/residence permit before coming to the Czech Republic.

Students are obliged to contact the nearest embassy or consulate for detailed information.

### **Health and Travel Insurance:**

All students must hold a valid European Health Insurance Card (EHIC) or equivalent before coming to the Czech Republic.

Visa students need to buy Comprehensive Health Travel insurance in accordance with the instructions of the Ministry of Interior of the Czech Republic.
