

## **Reduction of Accommodation Fees at the University of Hradec Králové Dormitory**

1. Due to the exceptional measures by the Ministry of Health related to the ban of personal attendance of students for studies at the university based on the preventive actions against the spread of COVID-19 dated March 10, 2020 (hereinafter "exceptional measures"), it was recommended to the students accommodated at the UHK Dormitory to return to their homes.
2. Due to the limited usage of accommodation capacities and validity of all the statements in the contracts of accommodation, the accommodation fees will be reduced to 50% since April 1, 2020 for students who have signed the contract before April 1, 2020 and the contract lasts for minimum of 30 days. This reduction lasts until the last day in the month when the exceptional measures end and personal attendance at the university is allowed.
3. Accommodation price list is stated in the Attachement no. 1 of this Directive. This replaces Art. 2 of the Bursar's Directive no. 02/2019 - the Student Accommodation Price List of the University of Hradec Králové Dormitory.
4. The reduction of accommodation fees aims to:
  - a. ensure high standard of the accommodation services at the UHK Dormitory in the period of the exceptional measures,
  - b. ensure fluent arrival for accommodation when the exceptionals measures are over,
  - c. ensure that the UHK students have enough support for study obligations.
5. In case of a notice given by an accommodated student before April 1, 2020, valid halls of residence rules of the University Halls of Residence and the Bursar's Directive no. 02/2019 - The Student Accommodation Price List of the University of Hradec Králové Dormitory will be followed. The one-month notice period is still valid and will begin on the first day of the following month when the notice is given according to Art. 6, Par. 1, Letter c) of the University Halls of Residence Rules. Basis for the calculation of the accommodation fee is counted according to the fees stated in the Art. 2 of the Bursar's Directive no. 02/2019 - The Student Accommodation Price List of the University of Hradec Králové Dormitory.
