M05.1-Valuation

2 Description of Module

The Valuation module contains basic information on the topic of intellectual property assets valuation. It deals with three basic valuation principles and methods that can be used. In order for an IP asset to be valued, it must meet certain conditions. Valuable intellectual property must be independently identified, transferable and have an economic life. It is necessary to obtain and verify a large number of relevant documents for the valuation itself, as all the information obtained will help the expert to select a suitable valuation method. Likewise, the purpose of the valuation has a fundamental influence on the choice of the valuation principle as well as the valuation methods. The module summarizes the various possible purposes of valuing IP assets so that participants have an idea of the importance of IP valuation and the possible legal and economic reasons for valuing IP assets.

3 Course Goals and Outcomes

Module goals are to point out the importance of intellectual property assets valuation, point out the difficulty of valuation process and explain the methods for IP assets valuation in three basic principles of valuation. Participants will gain an overview of the topic of IP valuation. The acquired knowledge they will be able to use later in practice. They will be able to identify the appropriate purpose of the IP valuation as well as the extent of the necessary documentation.
