

# Accommodation Schedule in the Academic Year 2025/2026

#### University of Hradec Králové, Halls of Residence

#### Article 1

# I. Applications for accommodation for students studying in a complete study programme, with the exception of future first grade international students who pay the tuition fee

Applications for accommodation may be submitted no sooner than after the student's admission for the study.

Application for accommodation shall be submitted on the ISKAM web interface at <u>ubytovani.uhk.cz</u>.

#### Round I (current UHK students)

## Round II (future first grade student + current UHK students who did not apply in the Round I, students of other universities)

#### Round III (UHK students, students of other universities)

#### Vacancy capacity reserved for applications submitted in Rounds I and II:

Round I: A maximum of 400 students will be accommodated.

Round II: Remaining vacancies after satisfaction of applicants

in Round I and international exchange students (Erasmus) + international students paying tuition fee in a programme taught in a foreign language.

The method of evaluation of applications is specified in Article 3 of the UHK Halls of Residence

Rules.

### Procedure for determining the date of arrival for accommodation and bed reservation for students of all applications approved in Round I and II:

The student must reserve the date of arrival **twice** in the following way:

- 1) First, the student reserves the date of arrival (date and time) in the UHK reservation system (e.g., 15 September 2025 between 13:00 and 13:45).
- 2) Then he/she makes a bed reservation in the approved application for accommodation in the ISKAM system <u>ubytovani.uhk.cz</u> for the same date he/she has chosen in the UHK reservation system (e.g., 15 September 2025, room B16L).

In case of discrepancy between the starting dates of accommodation in the UHK reservation system and the ISKAM accommodation system, the UHK Halls of Residence reserve the right to decide on one of the dates thus booked on which the student shall be accommodated.

In case of interest in pair accommodation, both students, after fulfilling the booking conditions, first book a bed in an apartment of the same gender (in case the pair room is not available) and immediately contact the accommodation office via <a href="mailto:koleje@uhk.cz">koleje@uhk.cz</a> with the request for pair accommodation and with both names of the couple and their dates of birth and contact details.

For applications submitted in Round I and II, the right to accommodation ceases if the deposit is not paid and credited to the account of the UHK Halls of Residence within the period required. In exceptional and justified cases, the deadline for sending the Booking deposit may be extended individually; however, the student has to request such extension in writing **before** the expiration of the deadline and has to provide reasons for not being able to pay the Booking deposit.

The student can request by e-mail to koleje@uhk.cz to cancel the submitted application with the right to a refund of the Booking deposit within the following period:

• for applications submitted in Round I by 1 August 2025

• for applications submitted in Round II by 8 September 2025

• for applications submitted in Round II within 14 days from the application

approval and if the bed is occupied

by a substitute student

The Booking Deposit shall be converted into an Accommodation Deposit of the same amount upon arrival at the accommodation. The surplus of the Accommodation deposit after the end of the accommodation and offsetting of any receivables shall be refunded to the bank account of the student within 30 days.

To refund the Accommodation deposit to the bank account, please fill in the bank data on the ISKAM web interface. The surplus of the Accommodation Deposit, or part thereof, are sent:

- To accounts held with domestic banks;
- If the student does not have an account with a domestic bank, the surplus can be refunded in cash;
- If the Booking Deposit or accommodation payments have been paid via the payment gateway, the resulting surplus can be refunded in the same way, i.e., via the payment gateway (both payments and refunds of surpluses can be used by both domestic and international students). Surpluses can only be refunded to the student via the payment gateway up to the amount paid via the payment gateway. (e.g., if a student has paid a booking/accommodation deposit of CZK 2,000 via the payment gateway, a maximum of the same amount will be refunded via this method; any further surpluses exceeding the amount of payments made via the payment gateway cannot be refunded via the payment gateway);
- International students who do not have an account with a domestic bank may, by prior written agreement, request the refund of any surplus to a foreign bank account. In this case, all necessary payment details must be provided in writing in advance of the student's check-out from the University Halls of Residence.
- The University Halls of Residence reserve the right to decide how to refund any surplus incurred.

# II. Applications for accommodation for students studying in an exchange programme (Erasmus) + future first grade international students of a study programme taught in a foreign language who pay a tuition fee

Future first grade international students of a study programme taught in a foreign language who pay a tuition fee and Erasmus students do not apply themselves. Accommodation is guaranteed to the students based on a list of students from the Study Department of the respective UHK faculty submitted by the deadline below. Requests for the change of the bed reservation or of the starting date of accommodation can be accepted by maximum 1 September 2025 for students accommodated in the winter semester and by maximum 31 January 2026 for students accommodated in the summer semester. The choice and reservation of a bed is fully within the competence of the Accommodation Office of the UHK Halls of Residence. The international student listed on the list of students of the faculty shall make an Accommodation Contract on the day of arrival and pay the Halls of Residence Rent, the fee for vacancy if he/she arrives for accommodation later and

the Accommodation deposit according to No. 3, par. 7 hereof. In the case of failure to pay the Accommodation deposit, the fee for vacancy or the Halls of Residence Rent for a given month, the University Halls of Residence may unilaterally terminate the Accommodation Contract with such a student who is then obliged to leave the Halls of Residence on the next working day. Student receiving a scholarship from UHK shall pay for his/her accommodation upon receipt of this scholarship, but no later than 3 weeks from the date of the Accommodation Contract making. The dates for booking a bed for international\_students and the terms and conditions for Halls of Residence Rent payments are specified in details in Articles 2 and 3 hereof.

Deadline for provision of the list of students by respective UHK Faculties:

- International students requiring accommodation in the winter semester: by 25 July 2025
- International students requiring accommodation in the summer semester: by 12 January 2026

#### Article 2

#### **Dates of Accommodation**

The dates of accommodation in the UHK Halls of Residence in the academic year of 2025/2026 are as follows:

- 1) 15 September 2025 19 September 2025,
   22 September 2025 24 September 2025
  - for students in the full study programme under Art. 1, par. 1 (submission of applications in Round I and II).
  - The first day of accommodation (check-in) is the date filled in by the student in the application for accommodation on the ISKAM web interface (it is the date from which the student starts paying for his/her accommodation, regardless of his/her actual arrival to the Halls of Residence). The UHK Halls of Residence reserve the right to limit the number of students for boarding on individual days (individual check-in days reserved for students are limited by the maximum number of the students; after meeting the specified daily accommodation capacity, the students in such a case choose another day of arrival from the accommodation dates offered). Boarding is only possible on working days from 7:00 a.m. to 6:00 p.m. on the basis of the prepaid September 2025 Rent (see Article 3, par. 6 hereof).

• After the date specified, accommodation is still possible, provided that the Rent for the given month is paid and a later start of accommodation is announced to in advance and confirmed by the Accommodation Office (e-mail: <a href="koleje@uhk.cz">koleje@uhk.cz</a>). Otherwise, the Accommodation Contract and reservation are cancelled in accordance with the terms and conditions of the Accommodation Contract without the right to a refund of the Booking deposit.

#### 2) 12 September 2025 – 31 October 2025

- for international students requiring accommodation in the winter semester.

#### From 2 February 2026

- for international students requiring accommodation in the summer semester.

Deadlines specified in this paragraph apply to international students listed by faculties under Art. 1(2) hereof. The starting date of accommodation of international students means the day listed on the list of international students requiring accommodation in the winter semester provided by the faculties by 25 July 2025 and the day listed on the list of international students requiring accommodation in the summer semester provided by the faculties by 12 January 2026. The starting date of accommodation of such students can only be changed by 1 September 2025 and 31 January 2026, respectively. By this date all changes concerning entry of students must be submitted by the respective faculty to the Accommodation Office of the Halls of Residence. If an international student starts the accommodation after the date of his/her reservation according to the faculty list, he/she shall pay a fee for the vacant bed at the time of starting the accommodation in the amount of 50% of the Rent, from the date of the beginning of the reservation to the date of the beginning of the accommodation. If the international student does not arrive for accommodation in the winter semester of the given academic year by 31 October 2025, he/she loses the right for a bed reservation and the bed will be offered to the next person interested in accommodation. In this case, the relevant UHK faculty will also be notified of the cancellation of the international student's bed reservation. International students accommodated in the winter semester are guaranteed accommodation by 26 January 2026. After this deadline, they will get accommodation if there are vacant places in the summer semester. If such student continues his/her studies at the UHK in the summer semester, his/her right for accommodation continues as well.

#### Article 3

#### **Rent Payment**

- 1) Payment by direct debit: on the 5<sup>th</sup> day of each month. The rent may be paid by direct debit in the period from October 2025 till June 2026.
- 2) Payment by a bank order, payment gateway (via the ISKAM accommodation system: <a href="https://www.ubytovani.uhk.cz">ubytovani.uhk.cz</a>), or in cash/by a card at the UHK Halls of Residence reception desk: by the 15<sup>th</sup> day of each month.
- 3) From the 16<sup>th</sup> day of the specific month, a late payment fine shall be paid according to the pricelist in effect.
- 4) The Rent shall be paid in the amount calculated as the product of the daily rate for the relevant room according to the price list in effect 1 and the number of calendar days in the specific month (therefore, it is not possible to set up a monthly standing order to pay the Rent and we prefer the direct debit payment instead).

Example of payment calculation for September 2026, for reservations from 15 September 2026:

Number of days × rate per room 16 × CZK 143 (2 beds modernized) = CZK 2,288

**Variable symbol:** to be found in the student's general data in the ISKAM accommodation system.

5) In the direct debit payment, the student has to give permission to it in their internet banking with a sufficient amount limit (maximum Rent is CZK 4,433 based on the chosen accommodation standard) in favour of the UHK Halls of Residence account. At the same time, the student has to give permission to the direct debit on the ISKAM web interface (ubytovani.uhk.cz). If the direct debit payment fails (e.g. due to insufficient funds on the student's account or the direct debit insufficient limit or an incorrect account number), the student can pay the Rent through the bank order or in cash at the reception desk by the 15th day of the given month.

- 6) The September 2025 rent is paid cashless (via a bank transfer or payment gate) before arriving to the Halls of Residence according to the daily rate specified in the accommodation price list for the academic year of 2025/2026 and from the date selected as the day of the student 's arrival at Halls of Residence when submitting the application see Article 2 Dates of Accommodation. In case of non-payment of the Rent for the month of September, the student shall not be accommodated until the payment is made. On the arrival day to the Halls of Residence, the Rent for the month of September must be credited to the bank account of the UHK Halls of Residence.
- 7) International students pay for the accommodation on the day of their arrival or no later than the next working day at the Halls of Residence reception. At the same time, they also pay the accommodation deposit of CZK 2,000, which is the same amount as the Booking Deposit (the Accommodation Deposit is paid on the day of arrival by all international students, regardless of receiving a scholarship from the UHK). In the event of a late arrival outside of the date reserved for the accommodation, the student shall pay a charge for the unoccupied bed corresponding to 50% of the price of the Rent for the period from the reservation made until the date of actual arrival. If a student arrives for one semester only (Erasmus), he/she shall pay the Rent for the whole period of this semester on his/her arrival. An exception is made for students who will be paid a scholarship from the respective UHK faculty; they shall pay the one-semester Rent no later than 3 weeks from the date of their arrival (by this date such a student receives a scholarship from the respective UHK faculty). International students arriving to study for the entire academic year pay for their accommodation on a monthly basis, always by the 15th day of each month.
- 8) Students can follow their payment transfers through the ISKAM web interface.
- 9) Other conditions of the Rent payment are specified in the Accommodation Contract.
